The OCIAA Athletic Directors Workshop was called to order at 9:40 a.m.

- Approval of Minutes of last meeting on June 16, 2015
   Motion to approve the minutes of the June 16, 2015 OCIAA Athletic Directors Workshop was made by Mr. Michael Kroemer (Cornwall) second by Ms. Suzanne Lendzian (Fallsburg). All in favor. Motion carried.
- 2. Section IX Executive Director Mr. Greg Ransom Mr. Ransom stated he will be attending OCIAA Athletic Directors Workshops throughout the school year.
- 3. OCIAA President's Report Mr. Michael Bellarosa Mr. Christopher Mayo, Interscholastic Athletic Coordinator, gave the OCIAA President's report in Mr. Bellarosa's absence.
  - A. Section IX Combining of Teams Application

Mr. Mayo reported committee members met to discuss some of the problems in combining of teams in the past and what could be changed. The application process for combining of teams was explained by Mr. Mayo. The approval process has changed for approval by the Leagues is made prior to the School District Board of Education approval. Mr. Mayo asked athletic directors to discuss this with their Superintendent. A vote to approve the Section IX Combining of Teams Application will take place at the next OCIAA Athletic Directors Workshop on September 22, 2015.

B. Highland Residential Center Application
Motion made by Mr. Kurt Buddenhagen (Liberty) second by Mr. Ron Semerano (Port Jervis) to
approve Upton Lake Christian School as Friend and Neighbor to Section IX. All in favor.
Motion carried.

Highland Residential Center has applied for NYSPHSAA membership. The MHAL has voted to approve them as Friend and Neighbor status only. Motion made by Mr. Michael Kroemer

(Cornwall) second by Mr. Gary Vyskocil (Washingtonville) for OCIAA to approve Highland Residential Center as Friend and Neighbor to Section IX. All in favor. Motion carried.

- C. Coaching Certification Proposal
  Refer to Proposal in folder. Mr. Greg Ransom, Section IX Executive Director, explained this proposal is for private and parochial schools to comply with all coaching certification
  - requirements. Motion to approve was made by Mr. Tim Bult (Minisink) second by Mr. Ron Semerano (Port Jervis). All in favor. Motion carried.
- D. 10<sup>th</sup> Football Game

A 10<sup>th</sup> football game has been approved by NYSPHSAA. Mr. Greg Ransom explained that this proposal had originated in Section I and must have Section approval for the 10<sup>th</sup> game to be played. Mr. Mayo explained the 10<sup>th</sup> game would be played at the discretion of individual school districts. Motion made by Mr. Greg Sirico (Warwick) second by Mr. Michael Kroemer (Cornwall) for Section IX to approve the 10<sup>th</sup> game. All in favor. Motion carried.

4. NYSPHSAA Summer Meeting Report – Mr. James Osborne, Section IX Secretary/Treasurer

Mr. James Osborne stated 2015-2016 Section IX Directory, admission passes and sample soccer balls are available for each school.

Mr. Osborne reviewed the NYSPHSAA Summer Meeting. (Refer to report in the folder.) Highlights of the meeting include:

- ❖ Coaching Certification through National Federation (NFHS) as a pathway to coaching certification in New York State.
- ❖ APP and Mixed Competition (topic of discussion at NYSPHSAA Mandated Workshop on September 11<sup>th</sup>).
- ❖ Handbook Committee revision for Rule 39 in football.
- \* Hard shelled helmets approved in Baseball. Requirement not approved in Softball.
- NYSPHSAA Sportsmanship Committee added language to Sportsmanship Standard #27. This was not approved by Section IX.

- 5. OCIAA Athletic Coordinator Report Mr. Christopher Mayo

Mr. Mayo welcomed Annette King to the OCIAA staff. Annette will work as Account Clerk to the Regional Office of Interscholastic Athletics. Everyone introduced themselves to Annette King.

Mr. Mayo discussed the use of spikes for Modified Cross Country. Both Leagues had previously approved the proposal to allow a pilot program in New York State to allow use of spikes in Modified Cross Country. The Leagues then would decide whether to participate in the pilot program. If spikes are used it will require a report be made to NYSPHSAA if injuries occur. The MHAL voted not to use spikes for Modified Cross Country. No motion was made by OCIAA to approve the use of spikes in Modified Cross Country. The OCIAA will not use spikes in Modified Cross Country.

Mr. Greg Sirico, Executive Board NYSHSFCA (Warwick) discussed the Percentages Proposal for Football. Mr. Sirico discussed this proposal suggests not to compete with a school more than 2 ½ times its size. Motion to approve support of the Football Proposal was made by Mr. Tim Bult (Minisink) second by Mr. Greg Sirico (Warwick). All in favor. Motion carried.

Motion made by Mr. John Landro (Tuxedo) second by Mr. Michael Kroemer (Cornwall) to accept the Section IX Athletic Agreement with Anaconda Sports/Lids East for the five-year period 2016-2021. All in favor. Motion carried.
